Board Member Mallie gave a facility plan update to include: Old Gym flooring holes are repaired, the District Lobby lighting will be finished as soon as the lights are delivered, the CTE addition classrooms are almost ready for paint, the landscaping to prepare for concrete around the CTE addition will be happening in the next couple of weeks. Board member Richey thanked Superintendent Pino for her focus on honoring our history as we walk towards the future.

Superintendent Pino spoke about the annual IASB Convention coming up in November. All Board members are invited to attend.

Secondary Principal Leighty gave a report on the District Career and Academic Planning (DCAP). The team meets annually in the Spring to set individual and district goals for the following school year. He spoke to the use of Xello and field trips to help with career and college readiness goals and exposure for students.

Secondary Principal Leighty also reported on the following: Parent Teacher Conference attendance, Thanked the student success team and students' for their hard work for grades at the end of first quarter, RPP Perkins funding for special projects and a CTE Grant, and congratulated Ms Bowdre (MS Science) on her accomplishments this summer with her volunteer service with Johnson County Conservation at Kent Park and having a lesson published on Iowa PBS.

Elementary Principal Brown reported on the following: House File 2618 Personalized Reading Plan, 98% participation in Fall Parent Teacher Conferences, Literacy & Math scores, All first semester emergency drills are completed, and the upcoming Halloween celebrations.

Athletic Director Horman reported on the season ending for some of our fall sports and the success they have had this season. It was noted that Lisbon will be hosting up to three postseason football games. The High School Marching Band received a Division I rating at State Marching Band. The Band has seen great growth and with approximately 190 kids in grade 5th - 12th grade participating. Junior High Wrestling and Girls Basketball will be starting their seasons shortly. Board Member Alan Mallie also commented on the student participation in the National FFA Convention in Indianapolis.
